## 2011 CARLISLE EVENTS GIVEAWAY SWEEPSTAKES OFFICIAL RULES NO PURCHASE NECESSARY TO ENTER OR WIN.

1. **Sponsor:** The Sponsor of the 2011 Carlisle Events Giveaway Sweepstakes (the "Sweepstakes") is Carlisle Productions, Inc., 1000 Bryn Mawr Road, Carlisle, PA 17013 ("Sponsor"), which sponsors annual collector car, truck and motorcycle events at the Carlisle Fairgrounds in Carlisle, Pennsylvania ("Carlisle Events").
2. **Eligibility:** The Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia and Canadian residents (except Quebec) who are licensed drivers and are at least 18 years of age (for Canadian residents, over the age of majority) as of April 26, 2011. Void in Guam, Puerto Rico, the U.S. Virgin Islands, and other U.S. territories and possessions and where prohibited by law. Employees of Carlisle Productions, Inc. and its parent companies, subsidiaries, and affiliates, and their respective agents, advertising and promotion agencies, Sweepstakes partners and prize suppliers, and all local sponsors of the Carlisle Events and all of their respective affiliated companies, employees, officers, directors and shareholders ("Related Entities") and the members of their households and their immediate families (spouses, parents, siblings, children and each of their respective spouses) are not eligible. The Sweepstakes is subject to all applicable federal, state/provincial and local laws and regulations.

The Sweepstakes entry period begins at 12:00:01 AM Eastern Time ("ET") on April 26, 2011 and ends at 1:59:59 PM ET on August 28, 2011, with individual giveaways ending at specific times on the Saturday and Sundays of Giveaway Events, as set forth below ("Giveaway Day(s)"). Sponsor's clocks are the official time-keeping devices for the Sweepstakes.

11. Sunday, July 24, 2011 at 1:59:59 PM ET ("Eleventh Giveaway");
12. Sunday, August 7, 2011 at 1:59:59 PM ET ("Twelfth Giveaway"); and
13. Sunday, August 28, 2011 at 1:59:59 PM ET ("Thirteenth Giveaway").

\* Coyote Countdown: Carlisle Events has teamed up with Ford Racing and Kurgan Motorsports of Braselton, Georgia for this unique, onsite Coyote 5.0-liter engine swap. Kurgan will drive a tired-but-still-running 1993 Mustang coupe to the Giveaway Event and then, beginning on Friday, June 3, with the clock counting down, technicians will remove the Fox Body Mustang's original, worn V-8 and replace it with a brand-new Ford Racing "Coyote" 5.0 V-8 crate motor at a special display at the Giveaway Event.

4. **How to Enter:** NO PURCHASE NECESSARY. Two ways to enter all Giveaways, except the Coyote Countdown (see below): (1) Onsite Entry. Individuals who attend a Giveaway Event may enter the Sweepstakes at the Carlisle Events Giveaway kiosk located adjacent to the guest services trailer next to the grandstand (except for the Coyote Countdown Fourth Giveaway, which can only be entered with an Online Entry). Simply type in your first and last name, complete mailing address, email address and home and cellular telephone number (or scan your driver's license to populate the name and address fields) at the kiosk anytime before the deadline on the Giveaway Day at the Giveaway Event, as shown in the schedule above, and automatically be entered to win that day's giveaway. For opening gate times for each Giveaway Event, visit <http://www.carlisleevents.com> ("Website") or review each Giveaway Event publication available onsite. Opening times are subject to change at Sponsor's sole discretion. (2) Online Entry. You may enter the Sweepstakes by logging online to <http://www.carlisleevents.com/giveaways> between 12:00:01 AM ET on April 26, 2011 and the deadline on the Giveaway Day, as shown in the schedule above, selecting and completing the online registration form for the Giveaway Event you wish to enter and clicking "submit." You will be asked to provide your first and last name, complete mailing address, email address and home and cellular telephone number. After you click "submit," you will automatically be entered into the applicable drawing.

Coyote Countdown: Online Entry Only. Entrants to the Coyote Countdown, the Fourth Giveaway, can submit their guess, as to how long the swap will take from start to finish ("finish" shall mean the moment the Mustang moves under its own power following the engine swap), online on the Website. The entry with the closest estimated completion time without exceeding the actual official time that it took to complete the Coyote engine swap will win. Numerical entries must be made in hours and minutes only (no seconds). If there is a tie, the earliest submission with the closest time without exceeding the official time to complete the task is selected as the Fourth Giveaway Grand Prize Winner.

Entry in one Giveaway Event does not constitute entry into any other Giveaway Event. One entry per Giveaway Event per person is allowed. All entries become the sole and exclusive property of Sponsor and receipt of entries will not be acknowledged or returned. Sponsor is not responsible for technical failures of any kind or for lost, late, damaged, misdirected, illegible, stolen, incomplete, invalid, unintelligible, misdirected, altered, technically corrupted or garbled entries, which will be disqualified, or for problems of any kind whether mechanical, human or electronic. Only fully completed entry forms are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsor.

5. **Winner Selection/Random Drawing:** During the 2011 Carlisle Events season, a total of thirteen (13) winners will be selected. On the Giveaway Day during each Giveaway Event (except for the Coyote Countdown, see details below), the Grand Prize Winner will be selected in a random drawing from among all eligible Onsite Entries entered at the kiosk up until the deadline on the Giveaway Day, as shown in the schedule above, and all eligible Online Entries for that particular Giveaway Event received between 12:01:00 AM ET on April 26, 2011 and the deadline on the Giveaway Day, as shown in the schedule above. Non-winning entries will not be rolled over into subsequent draws for other Giveaway Events. The random drawing will be conducted by Sponsor, whose decision is final on all matters relating to the Sweepstakes. Odds of winning the prize will depend on the number of eligible entries received for each applicable drawing. Winner need not be present at the Giveaway Event to claim prize.

Coyote Countdown: Grand Prize Winner is based on the Online Entry time estimate submitted for completion of the Coyote swap as compared to the official Fourth Giveaway time clock where the earliest submission with the closest time without exceeding the official time to complete the task is selected as the winner.

Third Giveaway Grand Prize. The Third Giveaway Grand Prize will be delivered to the Third Giveaway Grand Prize Winner's residence at Sponsor's sole expense, if Third Giveaway Grand Prize Winner's residence is located in the continental U.S. If Third Giveaway Grand Prize

Winner's residence is located outside the continental U.S., such winner will be charged all applicable delivery charges. All other fees and expenses listed in these Official Rules, including special handling charges at time of delivery, for example, lift-gate service, shall be the Third Giveaway Grand Prize Winner's sole responsibility no matter the location of such winner's residence.

Winner must be a licensed driver and hold a valid driver's license and will be required to provide proof of insurance in order to take delivery of Grand Prize. If Grand Prize is a motorcycle, Grand Prize Winner must have a valid driver's license which permits operation of a motorcycle in the Grand Prize Winner's state or province of residence.
